

TERMS FOR ACCOUNT HOLDERS: Ready mix concrete and other building materials (unless otherwise quoted) are sold subject to 2% discount for payment by 10th of following month, net 30 days, provided all previous accounts have been paid. A 5% service charge per month (60% annual rate) will be applied to all past due accounts. Accounts that have become delinquent past 90 days are subject to be turned off and submitted for collections.

TERMS FOR CASH ON DELIVERY: Customers without an account and paying by check, cash, or credit card will be required to have a valid credit card on file before loading the first truck.

UNLOADING AND JOBSITE: 30 minutes allowed for unloading. Excess time charged at rate of \$40.00 per hour for first hour and \$50.00 per hour for each hour thereafter. Purchaser will provide suitable roads for delivery, otherwise delivery will be made at the curb or edge of paved road. All wrecker fees for mired trucks will be charged to purchaser. If purchaser desires to cross walks, curbs, drives, yards etc. will be crossed only at purchaser's, or purchaser's agent's risk.

CONCRETE MIX: All concrete strengths (P.S.I.) are calculated at a 4" slump. **We do not assume responsibility for strength or quality of concrete when slumps in excess of 4" are ordered.** We do not assume responsibility for slump, strength, or quality of concrete when water or any other material is added by the purchaser or at his or her request on the jobsite. Refusal of signature by customer upon arrival will be considered an approval to use ordered product. Our responsibility ceases immediately upon delivery. All loss or damage by the elements or from any other causes after unloading is at the purchaser's risk. Any shortage must be reported to the plant manager while concrete is in the plastic state so measurements can be made.

Purchaser waives all liability from Concrete Materials Company when Self Hauling and assistance on calculating square footage, total tonnage required, or customer provided measurements. This is to include building materials, concrete, and loose materials such as rock, sand, mulch, or dirt. Purchaser assumes all risk when calculating payload capacity for truck bed or trailer hauling.

Saturday delivery of concrete has a 40-yard minimum. Orders that complete below the minimum yardage are subject to "Minimum Fee" which will be calculated with exact mix used on job up to 40 yard minimum. Scheduling cut off by 2PM Thursday for Saturday concrete. Fee free cancellation by 3PM Friday. Cancellations past 3PM Friday or Saturday are subject to \$500 fee (including weather cancellations by customer).

DISCLAIMER: CMC does not guarantee the color of the concrete due to the numerous variables that impact the final appearance of concrete. Many factors affect the color of the finished product, including but not limited to: finishing techniques, workmanship, materials used, curing/sealing and the weather. A test pour is highly recommended to make sure the results meet your expectations.

THERE WILL BE A 30% RESTOCKING FEE ON ALL RETURNED MATERIAL. ALL RETURNS SHOULD BE ACCOMPANIED BY RECEIPT AND MUST BE WITHIN 30 DAYS OF PURCHASE. NO EXCEPTIONS.

A \$50.00 FEE WILL BE CHARGED FOR ALL RETURNED CHECKS
